SUBJECT: Consider Authorization of Recordation of the Notice of Completion for New Playground Equipment at Arroyo Vista Community Park, College View Park, Peach Hill Park, and Magnolia Park; and Authorize Release of Project Bonds

BACKGROUND

On June 2, 2010, the City Council awarded a contract to MICON Construction, Inc. in an amount not to exceed \$86,102 to provide installation of new modular play structures and swing sets at Arroyo Vista Community Park, College View Park, Peach Hill Park, and Magnolia Park. MICON Construction Inc. has completed its work and staff is requesting that the City Council authorize the recordation of the Notice of Completion.

DISCUSSION

The work began on June 25, 2010. All work was completed by September 30, 2010. With the Council's authorization to record the Notice of Completion, the City Clerk's Office will be authorized to release the project bonds in accordance with provisions as follows:

- Payment Bond # B20000741 shall be released six (6) months after recordation of the Notice of Completion.
- Performance Bond # B20000741 shall be released one (1) year after recordation of the Notice of Completion.

FISCAL IMPACT

STAFF RECOMMENDATION

Authorize the City Clerk to file the Notice of Completion for the project, and authorize the release of the project bonds as outlined above.
