SUBJECT: Consider Authorization for Recordation of the Notice of Completion for Rehabilitation of 1449 Walnut Canyon Road (APN 511-0-040-440) and Release of Bonds in Accordance with the Contract

BACKGROUND & DISCUSSION

On October 5, 2011, the City Council awarded the rehabilitation contract for 1449 Walnut Canyon Road (APN 511-0-040-440) to Magic Hammer Development, Inc. for \$37,365.00 plus a 10% contingency for an overall budget of \$41,102.00. As the work progressed additional work became necessary requiring two change orders totaling \$19,555.00 for a total project cost of \$56,920.00. On January 18, 2012, the City Council authorized a budget amendment to fund these change orders. Magic Hammer has satisfactorily completed all work and staff is requesting that the City Council authorize the recordation of the Notice of Completion.

With the City Council's authorization to record the Notice of Completion, the City Clerk's office will be authorized to release the project bonds in accordance with contract provisions as follows:

- Payment Bond No. 71184339 shall be released six (6) months after the recordation of the Notice of Completion
- Performance Bond No. 71184339 shall be null and void one (1) year after the recordation of the Notice of Completion.
