SUBJECT: Consider Authorization for Recordation of the Notice of Completion for Demolition at 161 Second Street (APN 512-0-102-210) and Release of Bonds in Accordance with the Contract

BACKGROUND & DISCUSSION

On July 18, 2012, the City Council awarded the demolition contract for 161 Second Street (APN 512-0-102-210) to Specialized Environmental, Inc. for \$9,842.00 plus a contingency of \$2,000.00 for an overall budget of \$11,842.00. There were no change orders for this project. Specialized Environmental has satisfactorily completed all work and staff is requesting that the City Council authorize the recordation of the Notice of Completion.

With the City Council's authorization to record the Notice of Completion, the City Clerk's office will be authorized to release the project bonds in accordance with contract provisions as follows:

- Payment Bond No. 1000877404 shall be released one (1) year after the recordation of the Notice of Completion
- Performance Bond No. 1000877404 shall be null and void one (1) year after the recordation of the Notice of Completion.
