SUBJECT: Consider Amendment No. 2 to the Agreement with Reel Life Pictures

BACKGROUND AND DISCUSSION

On September 21, 2011, the City entered into a two year Agreement with Reel Life Pictures for video production and operation services. This Agreement consists of providing video control and recording services for public meetings as well as production of special events footage as pre-approved by the City Manager.

On July 30, 2013, the City and Reel Life Pictures entered into Amendment No. 1 to the Agreement extend the term of the Agreement for one additional year.

Amendment No. 2 to the Agreement would extend the Agreement for the second one-year period which is authorized per the original Agreement language. Other than the one-year term extension, all other conditions of the original Agreement remain unchanged.

FISCAL IMPACT

There is no fiscal impact.

STAFF RECOMMENDATION

- 1) Authorize the City Manager to execute Amendment No. 2 to the Agreement with Reel Life Pictures subject to final language approval by the City Manager.

**AMENDMENT NO. 2
TO AGREEMENT BETWEEN THE CITY OF MOORPARK AND
REEL LIFE PICTURES FOR VIDEO PRODUCTION AND OPERATION SERVICES**

This Amendment No. 2 to the Agreement between the City of Moorpark, a municipal Corporation ("City"), and Reel Life Pictures., a video production and operations company, ("Contractor") for video production and operation services is made and entered into the _____ day of _____, 2014.

RECITALS

WHEREAS, on September 21, 2011, the City and Contractor entered into an Agreement pertaining to video production and operation services; and

WHEREAS, on July 30, 2013, the City and Contractor entered into Amendment No. 1 pertaining to the Agreement for video production and operation services, extending the term of the Agreement for an additional one (1) year period; and

WHEREAS, consistent with the language of the Agreement, the City wishes to extend the term of the Agreement for an additional one (1) year period which shall be the last extension.

NOW, THEREFORE, it is mutually agreed by and between the parties to amend the Agreement as follows:

I. Section 1, TERM, is amended by replacing this section in its entirety as follows:

The term of the Agreement shall be extended to September 30, 2015, unless sooner terminated as provided in Section 7, Termination or Suspension without Cause, of the Agreement.

II. Remaining Provisions:

Except as revised by this Amendment No. 2, all of the provisions of the Agreement shall remain in full force and effect.
