**SUBJECT:** Consider Resolution Appropriating of Funds from the General Fund Reserve for Waiver of Building Permit Fees to Rebuild Homes Destroyed or Damaged in the Shekell Fire

**BACKGROUND/DISCUSSION**

On December 20, 2006, the City Council directed staff to implement a fee waiver for building permits for the rebuilding of homes destroyed or damaged in the Shekell fire incident. The attached resolution appropriates \$4,000.00 from the general fund reserve for this purpose.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MOORPARK, CALIFORNIA, AMENDING THE FISCAL YEAR 2006/2007 COMMUNITY DEVELOPMENT BUDGET BY APPROPRIATING \$4,000.00 FROM THE GENERAL FUND RESERVE FOR WAIVER OF BUILDING PERMIT FEES FOR HOMES DESTROYED OR DAMAGED IN THE SHEKELL FIRE.

WHEREAS, on June 21, 2006, the City Council adopted the budget for fiscal year 2006/2007; and

WHEREAS, at a duly noticed City Council meeting on December 20, 2006, City Council directed staff to prepare a budget amendment allocating \$4,000.00 from the General Fund for waiver of building permit fees for homes destroyed or damaged in the Shekell Fire.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MOORPARK DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. A budget amendment in the aggregate amount of \$4,000.00 from the General Fund for waiver of building permit fees, as more particularly described in Exhibit "A" attached hereto, is hereby approved.

SECTION 2. The City Clerk shall certify to the adoption of this resolution and shall cause a certified resolution to be filed in the book of original resolutions.
